

## **Gunner Diamond Again Frozen Semen Contract**

We would like to take a moment to Thank You for considering "Rock" as part of your breeding program for this 2026 season!

I hereby agree on this day	2026, to contract with Triple R Equine	
LLC to breed the mare	, registration	
#(s)	to Gunner Diamond Again #6319913 for the fee of	
\$1,750.00 for the 2026 bro	eeding season, subject to the following terms and	
conditions.		

- 1. This signed breeding contract is to be returned with the non refundable booking fee of \$350.00 The stallion fee balance of \$1,400.00 and \$500.00 shipping fee is and due prior to the first shipment of frozen semen.
- 2. Fees set forth are in U.S. funds and a 5% credit card fee will be applied.
- 3. Mare owner agrees to provide a copy of the mare's registration paper(s).
- 4. This contract and semen shipped is only for the above named mare.
- 5. **Live Foal Guarantee**: Stallion Fee is for one live foal. A live foal is defined as a foal that stands and nurses without assistance. If the foal is born dead, mare owner agrees to furnish stallion manager written notification from a veterinarian within ten (10) days. In such case, a rebreed contract will be granted.
- 6. Breeding fees are non-refundable.
- 7. The rebreed must be executed during the current or the consecutive breeding season unless up front and in writing between mare owner and stallion manager.
- 8. If mare dies or becomes unfit to breed, the Mare Owner may return with a substitute mare during the breeding season, or the following season at no additional substitution fees or stallion fee.
- 9. The fee includes one breeding dose. Additional breeding doses can be sent during the calendar breeding season upon request at a rate of \$200.00 per dose plus shipping.

- 10. There will be no refunds on any unused straws. Unused straws are non transferable.
- 11. Only two breeding doses will be shipped at a time, unless otherwise agreed upon and in writing between mare owner and stallion manager.
- 12. Semen is shipped from Select Breeders Southwest. Mare owner agrees to pay all shipping fees and duties pertaining to shipping semen directly to Select Breeders Southwest. International fees may apply if applicable.
- 13. No semen will be authorized for shipment from stallion manager to Select Breeders Southwest until the signed contract and all fees have been signed, returned to stallion manager and paid in full.
- 14. **Embryo Transfers/ICSI breedings**: Mare owner agrees to notify stallion manager this is an embryo transfer breeding. In an event that multiple embryos are produced, mare owner agrees to pay a stallion fee of \$1,400.00 for each additional live foal. The fees for the additional foals from ONE breeding are due when the foal is born.
- 15. **Vitrified (Frozen) Embryos**: Mare Owner agrees to notify stallion manager that the embryo was vitrified within 48 hours of recovery. Mare owner must inform stallion manager of any thawing/transferring of vitrified embryos within 48 hours of that process. Any pregnancy, or lack of has to be reported within 45 days of implantation.
- 16. All insemination date(s) and pregnancy or lack of pregnancy results must be reported to the stallion manager by August 1<sup>st</sup> of the current calendar breeding season. A failure to report results will incur a late fee of \$200.00.
- 17. The mare owner agrees to comply with all respective breed registry requirements regarding the use and handling of the frozen semen.
- 18. Stallion manager agrees to furnish a signed registration application upon notification of a live foal, and all fees have been paid in full to the stallion manager.
- 19. There will be no exceptions to the terms of this contract and is not transferable unless agreed upon and in writing by stallion manager and mare owner.
